I confirm that the frozen drink machine(s) and rolling cart(s) I receive are in proper working condition, as demonstrated to me by The Los Jefes Margarita Machine and Rentals delivery personnel.

I acknowledge the following terms:

Support & Operation

I must call within the first TWO (2) HOURS of the rental period if I have any questions about operating the equipment.

Machine Placement & Freezing Conditions

I understand that if the machine is placed in temperatures of 80°F or higher, especially outdoors, it may not freeze properly due to environmental conditions.

This is my choice, and I acknowledge that no refunds will be given for non-freezing due to high temperatures.

Reporting Equipment Problems

All problems must be reported at the time they occur.

Reporting issues after the event or at the end of a multi-day rental will not be considered valid for compensation or correction.

In multi-day rentals, only the days reported at the time of the issue may be considered for resolution.

Power Requirements & Electrical Load

I understand the machine(s) must be:

Plugged into a 20 Amp, 110 Volt dedicated circuit

Not sharing the outlet with other appliances

Using only the extension cord provided

I will turn the machine ON 2 hours before the event and ensure it is switched to the frozen setting.

I have been advised to turn the machine OFF once empty.

If a service call is requested and the issue is due to electrical load problems (not a malfunction), I agree to a \$50 service fee.

No refunds will be given for electrical load issue

Liability & Equipment Use

I will not disassemble or attempt to repair the machine(s). Any damage caused by unauthorized repair attempts will be billed to me.

I understand that I am fully responsible for any theft or damage (physical or mechanical) to the equipment during the rental period.

I agree that Los Jefes Margarita Machine and Rentals and Ashford Nabors Enterprise, LLC is not liable for any personal injuries, accidents, or issues related to alcohol consumption during or after the event.

Power Requirements & Electrical Load

I understand the machine(s) must be:

Plugged into a 20 Amp, 110 Volt dedicated circuit

Not sharing the outlet with other appliances
Using only the extension cord provided

I will turn the machine ON 2 hours before the event and ensure it is switched to the frozen setting.

Mix Use & Payment Terms

- I will only use flavor mixers provided or approved by Los Jefes Margarita Machine and Rentals.
- I understand that 100% payment is due prior to delivery.
- A \$40 deposit is required at the time of reservation. Without this, the rental service is voided.

Delivery, Pickup & Fees

- If I or my representative is not available at the agreed delivery or pickup time, a \$50 return trip fee will be charged.
- At pickup, the equipment must be accessible or the return fee will apply.
- A \$50 late fee will be charged if the contact person is more than 25 minutes late to the agreed delivery/pickup time.
- I am responsible for any missing parts, including carts, mixing jugs, and accessories.

I have read and agree to the contract terms on the front and back of this invoice, which together constitute our entire agreement. I understand that there are no oral or other representations not included herein.
